

BUKH V8 Official Warranty Information

- I. BUKH warrants each new production BUKH V8 Engine including accessories attached thereto (hereafter referred to as "Product"), manufactured by BUKH, to be free from defects in material and/or workmanship. This warranty is only valid when the customer purchases or obtains pre-delivery service from a Dealer authorized by us to distribute BUKH products in the country in which the sale or pre-delivery service occurred. This warranty shall apply only to pleasure craft and light-duty craft applications.
- II. This warranty becomes effective upon the date of sale to the first purchaser or user of this product and after BUKH has received a completed warranty registration form on www.bukh.dk. The warranty period for Pleasure Craft application engines is one (1) year from the date of the sale to the first purchaser or the accumulation of 500 hrs of engine operation, whichever occurs first. The warranty period for Light-Duty Commercial craft applications is one (1) year from the sale to the first purchaser or user or the accumulation of 750 hrs of engine operation, whichever occurs first. Any unused period of the applicable warranty is transferable to any subsequent purchaser only if the required maintenance records have been recorded by an authorized BUKH-dealer. If the law applicable in the Country, State or Province where the product is sold prohibits limitation of warranty coverage to one (1) year the warranty shall be the minimum period required by local law. For purposes of this warranty Pleasure Craft is defined as a recreational planing craft used only and exclusively for pleasure and recreation. Light-Duty Craft is defined as a planing hull vessel used in any law enforcement, commercial, or professional entertainment activity, or used in any enterprise or venture in which revenue in any amount is generated directly or indirectly. For no planning craft please consult BUKH for warranty approval prior to sale. The warranty will provide in the First Year: Parts and Labor. In no case will the warranty cover the cost of removing or installing the engine in the boat, pulling the boat out of the water. lifts or other associated incidental costs see item VII.
- III. Purchaser must provide proof of purchase and substantiate the original date of sale and delivery by presenting to the dealer, authorized to service the Product, the original purchasers copy of the warranty registration confirmation. If either of these items is not available, purchaser must provide a copy of the original purchaser's "Bill of Sale" (Sales Contract) for the Product to be serviced. Warranty claims will not be accepted by the dealer until the original date of sale/delivery and Product serial number can be verified. BUKH service partners hand in claim registration form via www.bukh.dk.
- IV. It is a condition for the continuation of this warranty that the Product is to be taken to an authorized BUKH Service Dealer, after 100 hrs of engine operation, but not later than 150 hours for required checks and adjustments. A copy of the dealer service work order must be retained as evidence of the completion of this requirement. This is an owner expense.
- V. Since this warranty applies to defects in material and/or workmanship, it does not apply to normal wear, adjustments, tune-ups or to damage caused by:
 - 1) Neglect, lack of maintenance, accident, abnormal operation, improper installation or service.
 - 2) Use of a propeller not properly suited to application/boat load.
 - 3) Failure to follow instructions in BUKH V8 Owners Manual and BUKH V8 Maintenance Book.
 - 4) As applied to twin installation vessels; continual operation of the vessel on only one engine in any condition.
 - 5) Use of an accessory or part not manufactured or sold by BUKH.
 - 6) Operation with fuels, oils, lubricants or coolants/coolant additives which are not suitable for use with the Product or recommended by BUKH.
 - 7) Participating in or preparing for racing or other competitive activity.
 - 8) Alteration or removal of parts.
 - 9) Water entering engine cylinder/s through the exhaust system or air intake system.
 - 10) Use or operation of the product in a manner inconsistent with the "BUKH V8 Owners Manual" and "BUKH V8 Maintenance Book".
 - 11) Engine cooling system overheating or engine overheating.
 - 12) Failure to stop engine at any engine alarm.
 - Glow Plug Failure.
- VI. Reasonable access must be provided to the Product for warranty service. This warranty will not apply to:
 - Haul-out, launch, towing and storage charges, telephone or rental charges of any type, inconvenience, or loss of time or income, or other consequential damages or dealer errors.
 - 2) Removal and/or replacement of boat partitions or material because of boat design for necessary access to the Product.
- VII. Claim shall be made under this warranty by delivering the Product for inspection to a BUKH dealer authorized to service the Product. If the purchaser cannot deliver the Product to such authorized dealer, he may give notice in writing. BUKH shall then arrange for the inspection and repair, provided such service is covered under this warranty. Purchaser shall pay for all related transportation charges and/or travel time. If the service is not covered by this warranty, purchaser shall pay for all related labor and material, and any other expenses associated with that service. Any product or parts shipped by purchaser for inspection or repair must be shipped with transportation charges prepaid.
- VIII. BUKH obligation under this warranty shall be limited to repairing a defective part or, at our option, refunding the purchase price or replacing such part or parts as shall be necessary to remedy any malfunction resulting from defects in material or workmanship as covered by this warranty. The repair or replacement of parts, or the performance of service, under this warranty, does not extend the period of this warranty beyond its original expiration date. BUKH reserves the right to improve the design of any Product without assuming any obligation to modify any Product previously manufactured.
- IX. This warranty does not imply coverage for other manufacturers products used in combination with company products. Other manufacturers products used in conjunction with BUKH Products are warranted at their own discretion and specifically as indicated by each specific manufacturer.
- X. ALL INCIDENTAL AND/OR CONSEQUENTIAL DAMAGES ARE EXCLUDED FROM THIS WARRANTY. WARRANTIES OF MERCHANTABILITY AND FITNESS ARE EXCLUDED FROM THIS WARRANTY. IMPLIED WARRANTIES ARE LIMITED TO THE LIFE OF THIS WARRANTY. SOME STATES OR COUNTRIES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSIONS MAY NOT APPLY TO YOU.
- XI. In the event of any litigation with respect to the purchased product the parties agree the law for the country of Denmark shall apply. Further, the parties agree such litigation shall lie within the appropriate court in Denmark.
 - In the event that a warranty claim is required outside the country of Denmark, there may be additional charges not covered under warranty based on local practices and conditions, such as but not limited to freight, insurance, taxes license fees, import duties, and any and all other financial charges, including those levied by governments, states, territories, and their respective agencies which will be the responsibility of the purchaser.
- XII. This warranty gives you specific legal rights and you may also have other legal rights, which vary, from state to state and country to country.
